Honorable Michael Montez:

The Galveston County Auditor's Office has examined the monthly reports of Constable 1 - Texas City for the months of April 2015 through June 2015. The scope of the examination was limited to reviewing the records submitted to this office by Constable 1 - Texas City. The objectives of the examination were to verify the mathematical accuracy of the reports and to confirm all funds collected were deposited with the County Treasurer in a timely manner.

- Monthly reports reviewed were mathematically accurate and are therefore approved as submitted in compliance with LGC §115.002.

The office made 6 deposits during the audit period.

Finding: The office is not in compliance with LGC §113.022 and CCP §103.004, as deposits were made on average of 27 business days following the receipt of the collections. *(This was a previous finding.)*

Recommendation C5-15-01: Deposit collections the next business day after the date the money was collected. If this is not possible, deposit the money no later than the fifth regular business day after the money is collected.
