Honorable Jim Schweitzer:

The Galveston County Auditor's Office has examined the collections of Justice of the Peace, Precinct 2 (Galveston and Santa Fe offices) for the months of January 2015 through March 2015. The scope of the examination was limited to reviewing the records submitted to this office by Justice of the Peace, Precinct 2. The objectives of the examination were to confirm all funds collected were accounted for and deposited with the County Treasurer in a timely manner.

- All funds collected were accounted for during the review.

According to LGC §113.022 and CCP §103.004, funds collected shall be deposited to the County Treasurer as soon as possible, but not later than the fifth regular business day after the date the money is collected.

Finding: Deposits made during the audit period were not in compliance with LGC §113.022 and CCP §103.004.

Recommendation JP2-15-01: Deposit all collections to the bank daily or no later than the fifth business day after the day on which the money is received.
