**ORDER**


The Court, having considered *TWIA's Third Motion for Protection*, Plaintiff's response thereto, and the arguments of counsel as allowed, orders as follows:

ORDERED that TWIA's objections to these search terms are overruled and TWIA shall run the search terms attached hereto as "Exhibit 1" and produce the responsive documents to Plaintiff, and if a particular term results in an overly burdensome production, then TWIA can provide additional evidence of the burden to the Court and request protection after a hearing;

It is FURTHER ORDERED that no additional search terms will be added, absent a showing of good cause;

It is FURTHER ORDERED that the discovery TWIA produces in response to the attached search terms will be used by Plaintiffs in all cases against TWIA, and that the Mostyn Law Firm will maintain a repository of responsive documents for shared discovery with other Plaintiffs in suits against TWIA, and the Mostyn Law Firm will be responsible for producing these responsive documents in electronic form to other Plaintiffs' counsel..
