This letter shall constitute an agreement by and between Plaintiff Clear Creek Independent School District ("CCISD") and Defendants The City of League City, by and through The City Council for the City of League City, and Mike Clawson, Interim City Administrator, In His Official Capacity (collectively, "Defendants") pursuant to Texas Rule of Civil Procedure 11 in the above-referenced case (the "Case").

Pending the City Council of League City's consideration and vote on the Interlocal Cooperation Agreement between CCISD and League City on Monday evening, August 8, 2005, CCISD and Defendants hereby agree to suspend any and all deadlines for CCISD to file responsive pleadings to the following motions/pleas filed by Defendants:

- Defendants' Motion to Quash Plaintiff's Notices of Oral Deposition with Subpoenas Duces Tecum (to Chris Peifer, Mike Clawson, Jerry Shults, and Katie Benoit), Subject to Plea to Jurisdiction;
- Defendants' Motion for Protective Order Subject to Plea to Jurisdiction; and
- Defendants' Plea to Jurisdiction, Plea in Abatement, and Original Answer Subject to Plea to Jurisdiction and Plea in Abatement.
