Question #1: *Can we receive a copy of the CAD files, we were not able to make the site walk?*

Response: The County requests a drop box or some type of FTP site for uploading purposes. In all it's about 1Gb of data.

Question #2: *It was mentioned that the IDF's are stacked and a 2" conduit is available for vertical pathway, it there an existing roof penetration near the vertical riser for the ingress into the building?*

Response: Yes, there is a roof penetration with existing ½ 50 ohm coax not utilized.

Question #3: *It was mentioned that there are cable trays above the ceiling, can these pathways be marked on the plans?*

Response: I do not have a way to add to the original CAD drawings.

Question #4: *If there is any hard lid ceiling can these be marked on the plans?*

Response: 99% will be 2x2 drop tile. The furr down locations are minimal.

Question #5: *How many existing roof penetrations with 2" conduit are available?*

Response: There is currently one (1) for the purpose for cell ½" 50 ohm coax in the center MFD on the roof.

Question #6: *If more roof penetrations are required, will these be provided by the County of Galveston or should these be included in our quote?*

Response: Each roof penetration follows each wing's MDF. There are three (3) MDF locations on the roof that will provide adequate pass through.

Question #7: *Special Provisions page 4 state "No plastic covered antennas". Are we to assume that this would only apply to donor antennas and not to GPS antennas?*

Response: Only for the donor antenna due to the fact that the parabolic dishes tend to catch wind.

Question #8: *Will "Area K – Lobby and staff Floor Plan "(A2.24) be included in the DAS or just 1st through 4th floor of the "Life and Safety and Composite Plan" (A1.02-A1.05)? A2.24 appears to be a different building.*

Response: Please disregard. This project is only for the Justice Center.
