

The following information is being provided to aid in preparation of your bid submittal(s):

Question #1: Could you please add a trenching line item by the foot for the Crystal Beach location? There is 26 feet of trenching that will be required..

Response: The Department will perform manual labor of cleaning trench drain as routine maintenance. The Department only interested in vacuum/disposal services.

Question #2: Since a site visit was not scheduled for Texas City, we are unsure if trenching will be required. Could you add a line item for trenching just in case it is needed?

Response: There is no wash rack in Texas City or a trench drain.

Question #3: The lids and grates have not been removed at the Dickinson site for quite some time. Could you please have the lids and grates removed by Galveston County personnel at the first service to avoid any possible damage by the vendor?

Response: The Department will perform manual labor of cleaning lids and grates as routine maintenance. The Department only interested in vacuum/disposal services.
